#### NEWFOUNDLAND—COMMITTEE RECOMMENDATION TO RESTORE RAIL PASSENGER SERVICE—REQUEST FOR GOVERNMENT ACTION

**Mr. James A. McGrath (St. John's East):** Mr. Speaker, I should like to direct a question to the Minister of Transport. In view of the fact that the transport committee, under the distinguished chairmanship of the hon. member for Crowfoot, by an all-party vote last night recommended that the government restorate rail passenger service in Newfoundland, at the instigation of my colleague the hon. member for St. John's West, does the minister propose to take the necessary action to implement this all-party recommendation?

**Mr. Speaker:** Order, please. The minister might reply to the question, but the hon. member for St. John's East knows it is irregular to refer to a decision of a committee or to the proceedings of a committee until a report has been made. Perhaps the minister might be allowed to reply briefly to the hon. member's question which I believe is irregular.

An hon. Member: Say yes, Jean.

**Mr. McGrath:** Mr. Speaker, I would rephrase the question and, as a prelude, suggest to the minister that he confer with the distinguished chairman of the committee to find out what went on last night. Is the minister now prepared to expedite a study, which was commissioned by the department, into all phases of ground transportation in Newfoundland; and if that study has been completed, when will the minister report its findings to the House?

**Hon. Jean Marchand (Minister of Transport):** Mr. Speaker, the physical location of the chairman of the committee has nothing to do with my relationship with him. Although I do not know exactly what the committee decided last night, there is no doubt that we will have to study, and ask the CTC to study, the restoration of railway service in Newfoundland.

# STATUTORY HOLIDAYS
