return personal and confidential information about Canadians now in the United States, to Canada?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I am delighted that the hon. member is catching up with government policy. If he reads the Speech from the Throne he will see that we indicated action precisely in this area.

Some hon. Members: Hear, hear!

Mr. Baker: Mr. Speaker, I should like to direct a supplementary question to the acting government House leader. Can he tell the House when he is going to introduce the rather important piece of legislation to which the Prime Minister has called attention?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, the legislation is not yet ready and therefore it is difficult to indicate a specific date for its introduction, but it will be discussed further.

An hon. Member: Like the whole throne speech.

Mr. Speaker: Order, please. I would remind hon. members at this point that there are about four minutes left before the end of the question period and if hon. members want to ask further supplementaries that will take us to the end of the question period.

Some hon. Members: Oh, oh!

Some hon. Members: Hear, hear!

An hon. Member: That is a good word.

An hon. Member: Why did you not say "indicted"?

Mr. Trudeau: —as I indicated earlier in the House. The Minister of the Environment is responsible for his aspect of the question. The Minister of Indian Affairs and Northern Development, who of course would have jurisdiction for the territories, is involved, and of course so is the Minister of Energy, Mines and Resources. They have formed a committee and the spokesman, depending on the particular aspect of the subject, will be one of those three ministers and, if there is any doubt, it will be myself.

Mr. McKinnon: Mr. Speaker, I thank the Prime Minister but perhaps he could clarify it a little bit for the benefit of the House and the nation. Does the government feel that the National Energy Board as currently con-
