### COPIES OF CORRESPONDENCE BETWEEN SUNSET CREST LTD AND EMPLOYEES OF AIR CANADA

## Mr. Don Mazankowski (Vegreville) moved:

That an Order of the House do issue for copies of correspondence and agreements between Sunset Crest Ltd., now a subsidiary of the Barbados Shipping and Trading Co., and any employee of Air Canada or its subsidiaries

He said: Mr. Speaker, at the outset I must say that it is of utmost significance that this motion should follow the debate which just took place this afternoon, the debate on closure, which I believe illustrates that the government not only wishes to muzzle members of parliament and deny them the right to speak in this House on important issues, but here we have a motion which clearly illustrates the refusal of the government to provide information on a very important issue, an issue which is very timely, and the House is entitled to be provided with this information.

The reply to motion No. 36 was given by the former parliamentary secretary to the former minister of transport. This reply is similar in nature to many replies we receive from time to time on motions of this nature. The former parliamentary secretary, the hon. member for Battleford-Kindersley (Mr. McIsaac), pointed out the following:

The requested documents are of a proprietary nature and Air Canada believes this information should not be made public for competitive reasons. I therefore ask the hon. member to withdraw his motion.

That is recorded at page 4650 of Hansard for April 9, 1975. That is the standard stock answer which is peddled by this government every time we attempt to elicit information on this most favoured, pampered pet of the government, namely, Air Canada.

Air Canada has become a corporate disgrace. The former parliamentary secretary at page 4650 indicated that information was withheld for competitive reasons. This answer
