## Question No. 3,869-Mr. Nystrom:

- 1. Is the government going to be represented in the Rose Bowl Parade in Pasadena, January 1, 1976 and, if so (a) is the means of this representation going to be a floral banner (b) what is the cost of the floral banner?
- 2. Are personnel of the Department of National Defence, as well as personnel and horses of the RCMP going to be participating in events in Pasadena as well as other locations in California?
- 3. Will the Department of External Affairs be undertaking the cost of transportation of the contingent to California and, if so (a) what is the means of transportation (b) who will provide such transportation (c) what is the cost of such transportation?
- 4. Who and on what date authorized the payment of the transportation and how was it contracted out?
- 5. Will the Department of External Affairs be undertaking the cost of transportation of the contingent from one location to another within California and, if so, for each portion of the contingent (a) what will be the means of transportation (b) who will provide such transportation (c) what is the total cost of transportation (d) what is the cost of its travel itinerary?

- 7. - Hon. Allan J. MacEachen (Secretary of State for External Affairs): 1. Yes. (a) Yes. The floral banner headed the special Canadian section of the Tournament of Roses Parade; (b) \$7,500.

- 4. Contracts for the aircraft chartered from CP Air and Air Canada were signed on December 5, 1975. Two tenders were let and contracts were won by Air Canada and CP Air respectively. Charter costs totalled \$78,662. Additional air flights and ground transportation were required to connect with the charter aircraft and these were arranged by the Department of External Affairs.

Local ground transportation was by bus, truck or car as circumstances demanded; (b) Air service was provided by Pacific Southwestern Airlines.
