These grants have served to fund various demonstration projects, training projects, as well as the development of family planning services in Quebec's local centres for community services.

Funds for the development of family planning services were not paid directly to the treasuries of provincial or territorial governments, but to the relevant departments administering the funds. As well, some of the funds provided to the provinces through the Established Programs Financing Act and the Canada Assistance Plan may have been directed towards the development of family planning services, however, no specific amounts can be determined from these fiscal arrangements.

GUN CONTROL

Question No. 4,302—**Mr. Greenaway:**

1. Since January 1, 1979, by year, what amount did Government Departments and agencies spend on the enforcement of gun control regulations?

2. For the same period, by year, what amount did the Government collect through the sale of firearms acquisition certificates?

Hon. Bob Kaplan (Solicitor General): 1. Since the enforcement of gun control regulations is a provincial responsibility under the purview of the provincial Attorneys General, no reply can be provided to part 1.

2. Moneys collected by the Government through the sale of firearms acquisition certificates since January 1, 1979 are as follows: 1979-80—\$2,262,827; 1980-81—\$1,526,025; 1981-82—\$1,081,941.

ARMED FORCES ANNUITANTS AND DND PROMOTION POLICY

Question No. 4,324—**Mr. McKenzie:**

1. What is the total number of (a) Armed Forces annuitants (b) widows of Armed Forces annuitants (c) widows in receipt of an annuity due to the death of a spouse?

2. What is the total number of Armed Forces annuitants who died in each of the past 10 years, including the fiscal year 1980-81?

3. Did the Department of National Defence issue a directive number 4983-1B?

4. Did the Department issue an Order respecting Promotion Policy—Officers—Regular Force, OAF 11-6 and, if so, does the Order carry out the provisions set in directive 4983-1B?

5. With respect to paragraph 10 of the Policy, how many officers were in the "protected" category for 1981 and how many are projected to be in the "protected" category for 1982?

6. Of the total number of "protected" officers in 1981, how many were promoted when a new promotion quota was authorized for each particular rank and officer classification?

7. What are the Department's projected figures for promoting "protected" officers in 1982?

8. If a "protected" officer is not promoted, what is his/her employment status?

9. By priority, what are the elements of the merit system used by the Department in its hiring and promotion procedure?

Hon. J. Gilles Lamontagne (Minister of National Defence):

1. (a) The total number of Armed Forces annuitants as of March 31, 1982—60,462. (b) and (c) Total number of widows of Armed Forces annuitants in receipt of an annuity as at March 31, 1982—8,095.

Note: Records are not available of widows of Armed Forces annuitants not in receipt of an annuity.

2. The information regarding the number of Armed Forces annuitants who died in each of the past ten years is not readily available and would require a great deal of manual checking of records for which the Department does not have the necessary resources. However, broader data pertaining to discontinued annuities per fiscal year which includes deceased, re-enrolled and transfers to public service superannuation and RCMP is listed below:
