"(3) The Government of Canada shall provide sufficient funds to rehabilitate those railway branch lines, protected by order in council against abandonment to the year 2000, to a level of utility allowing reliable train service year-round in reasonable circumstances and such rehabilitation shall be disbursed by August 1, 1990."
