In fact the Government is committed to moving toward the goal of increasing our investment in science and technology to the economic benefit of Canada; to creating permanent jobs in the new areas of technology; and to continuing to support the Natural Sciences and Engineering Research Council and other initiatives of the Government in a very ambitious way, to the benefit of Canada and our young people.

MITEL CORPORATION—BRITISH TELECOM TAKEOVER PROPOSAL

Mr. Steven W. Langdon (Essex-Windsor): Mr. Speaker, I had a question for the Minister of Regional Industrial Expansion who has been acting like a wandering gypsy during this Question Period. If I could, I will direct my question to the Minister of State for Science and Technology.

An Hon. Member: Oh, here he comes.

Mr. Langdon: Here by popular demand. Yet more problems for Mitel are appearing from the proposed takeover by British Telecom, with the announcement made by Bell Canada that it is reconsidering its purchases from Mitel because British Telecom is one of its major rivals. Would the Minister commit

himself to meet urgently with Mitel management in order to urge them to adopt the 18 per cent minority proposal for participation rather than the majority takeover?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, as the Hon. Member undoubtedly knows, we intend in due course to meet with the Mitel people in order to hear more about the nature of the deal. With respect to the statement attributed to Bell Canada by The Globe and Mail, as the Hon. Member probably knows Bell Canada was investigated some time ago with respect to vertical integration in procurement practices. As a result of this story I have asked two of my colleagues, the Minister of Communications and the Minister of Consumer and Corporate Affairs, at least to check into the story to find out if there is some substance to what was reported by The Globe and Mail.

### **GOVERNMENT POSITION**

Mr. Mike Cassidy (Ottawa Centre): Mr. Speaker, my supplementary question is directed to the same Minister. Is it not activities like the kind of activity undertaken by his Ministry, in allowing a major corporation that is so involved in research and development to go into foreign hands, that contribute to the fact that the Government has now indicated publicly that it has abandoned its promise to double R and D spending in Canada by 1988?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, once again the Hon. Member is stating something that is just not true. We have not allowed or disallowed anything in that respect. All we have done is acknowledge that there is a deal and that in due course we will undoubtedly have an opportunity to review that deal.

I pointed out, and will point out once again for the Hon. Member, that Mitel was in difficult financial straits. The Hon. Member cannot have it both ways. This company has offered to put into Mitel over \$300 million of fresh equity, which will at least ensure that 2,500 Canadian jobs, and 5,000, including international, jobs will be preserved. I am on the side of the workers of Mitel, and I think it is time that the Hon. Member got on the side of the workers of Mitel as well.
