## COMMENTS DURING QUESTION PERIOD

I think this is an extremely serious matter, particularly given the exigencies of television coverage in this House and the fact that our responses cannot be seen. I feel my privileges have been breached. I would ask that you, Mr. Speaker, review this matter.

Hon. Doug Lewis (Minister of Justice and Attorney General of Canada): Mr. Speaker, I take the point my hon. friend raises. I would ask that if you, Sir, are prepared to do that, that you also examine the record. You will find that the member who makes the complaint suggested immediately thereafter that the Prime Minister was laughing.

Ms. Clancy: He was.
