COMPLEXITY OF CHILD TAX CREDIT APPLICATION FORM

Mr. Ray Hnatyshyn (Saskatoon-Biggar): Mr. Speaker, my question is for the Minister of National Health and Welfare. In a letter I received from her colleague, the Minister of National Revenue, the minister informed me that next year he anticipates having a much simpler form for those who will be filing only to obtain the child tax credit. He went on to point out in that letter to me that it should also be possible to develop more efficient processing routines and thus reduce the costs of administration.

I wonder if the minister would indicate whether she shares her colleague's point of view that the application form for the child tax credit has been unnecessarily complex this year and has cost the Canadian taxpayer a great deal of money in terms of additional administration?

Hon. Monique Bégin (Minister of National Health and Welfare): Mr. Speaker, I do not know if we are lacking questions in the House this afternoon, but this one surely is unnecessary.

Miss Bégin: I said several times in the debate on Bill C-10 back in November—the hon. member probably did not follow that debate—that we regretted having to ask the Canadian public to fill in schedule 10, which is complicated as are all tax forms, I must admit. I indicated that programs, training manuals and seminars for additional staff of Revenue Canada for the present fiscal period were already under way. That was explained very often, so the answer to the question of the hon. member is that I agree with my colleague that next year we will have a single, simple and shorter form for mothers.

PROTECTION AGAINST OIL SPILL FROM TANKER "KURDISTAN"

Mr. Bob Wenman (Fraser Valley West): Mr. Speaker, my question is to the Minister of State (Environment). With reference to the missing oil slick and the potential of a further oil leak, can the minister assure this House that should the situation get worse, he will remain in charge of the situation and carry it through to solution instead of transferring the matter to the Minister of Transport, provincial governments and municipal governments?

Should there be the problem of an oil slick working toward the shoreline and endangering the marine environment, will he assure us that what happened in British Columbia, where governments, argued about a solution to the problem, will not happen again? Will the minister assure the House that the procedure will not be followed and that he will take care of the problem instead of transferring jurisdiction?

Hon. Len Marchand (Minister of State (Environment)): Mr. Speaker, I will certainly carry out my responsibility. But the hon. member is just being mischievous in this case because he knows very well that in the case of this particular oil spill, the coast-guard and the Ministry of Transport are the lead agencies. I have no comments about that, but I want to assure the hon. member that all concerned departments of both the provincial and federal governments are working very closely together.

CASTLEGAR—JOB SECURITY OF EMPLOYEES
