However, if in the course of the audit it is noted that a department has failed to take appropriate collection action, the Auditor General or one of his officers would bring this to the attention of the department, and request an explanation. In the light of the explanation given, the Auditor General would then decide whether this reporting responsibilities under section 70 of the Financial Administration Act required him to include reference to the matter in his next annual report to parliament.

CLOSING OF FILM BOARD OFFICE, NEW GLASGOW, N.S.

## Question No. 1,509-Mr. MacEwan:

Has the government received a resolution from the New Glasgow area film council, New Glasgow, Nova Scotia, asking that the national film board office at New Glasgow remain open, and not be closed in November and, if so, what action does the government intend to take in regard to this important matter?

The Canadian economic foundation was incorporated without share capital under the Dominion Companies Act by letters patent on March 8, 1962, the purpose of which is stated to be to conduct research and to inform the people of Canada generally in a better understanding of the proper relationship between government, business, industry and labour in Canada operating under a free competitive enterprise system.

3. The application submitted by the foundation stated the work of the foundation was entirely educational, which is a charitable purpose in law.

4. To educate the public on how our economy works. The material submitted does not indicate participation in political activities.

The movement of workers from Canada to Iowa and Alabama, and vice versa, is so small that reciprocal agreements with these two states would be of little practical value.
