**LABOUR CONDITIONS****ST. JOHN'S, NFLD.—STEPS TO SETTLE  
LONGSHOREMEN'S STRIKE**

On the orders of the day:

**Hon. Michael Starr (Ontario):** I should like to direct a question to the Minister of Labour. In view of the fact that a strike of longshoremen in St. John's, Newfoundland, has been in progress for about four weeks can the minister tell us what steps are being taken to assist in bringing the parties together to bring about a solution of this problem?

**Hon. A. J. MacEachen (Minister of Labour):** The senior officer of the Department of Labour in the Atlantic provinces has been active in the situation for the past several days. The efforts undertaken by him and other officers of the department, in conjunction with a three man committee of the Newfoundland board of trade, have failed up to this time, and there is still quite a wide area of disagreement between the parties.

**Mr. Starr:** May I ask a supplementary question. In view of this failure, as the minister puts it, to bring the parties together, would not the minister consider trying to bring these parties together on his own initiative?

**Mr. MacEachen:** Yes, Mr. Speaker; if the circumstances warrant further intervention by the department, that intervention will be undertaken. The parties have rejected a proposal for binding arbitration and the employers, as I understand it, have rejected a proposal for the establishment of an industrial inquiry commission. In this situation, I assure the hon. member for Ontario that at

any moment at which further efforts at mediation might be helpful, they will be undertaken.
