2. How many prisoners have had such corporal punishment more than once?

Hon. L. T. Pennell (Solicitor General): 1 and 2. In federal institutions, corporal punishment is administered as a court order or as a sentence awarded by an institutional board of discipline. Corporal punishment, as a court order, was used as follows: 1957, 28; 1958, 14; 1959, 7; 1960, 17; 1961, 6; 1962, 11; 1963, 9; 1964, 22; 1965, 3; 1966, 3; Total 120.

In 34 of these cases, corporal punishment was used on two or more occasions to dis-

charge the court order.

Corporal punishment, a sentence as awarded by an institutional board of discipline, was used as follows: 1957, 15; 1958, 16; 1959, 24; 1960, 12; 1961, 67; 1962, 18; 1963, 96; 1964, 26; 1965, 7; 1966, 32; Total, 313.

17 of these inmates have had such corporal punishment more than once.

Under the provisions of the Parole Act the National Parole Board may, upon application therefor, revoke or suspend any court sentence of whipping.

As of 1967 and pursuant to a new directive, sentences of strapping awarded by an institutional board of discipline may not be executed unless and until approved by the Commissioner of Penitentiaries except where an inmate is found guilty of participating in collective riotous behaviour beyond normal methods of control, and instant use of corporal punishment may restore order.
