### COMPUTER DATA STORAGE OUTSIDE CANADA

# Question No. 986-Mr. Kaplan:

- 1. Does the government use computer facilities which store data outside Canada?
- 2. Which departments and agencies use such facilities and to what extent?

Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council): 1. and 2. The Department of Agriculture use on a limited scale for computer program development the Computer Time Sharing, Place de Ville, Tower A. (computer is at Boston, U.S.A.) and the Greyhound Computer of Canada Limited, 1740 Woodward Drive (computer is at Stanford, Conn., U.S.A.)

The National Research Council of Canada participates in continuing international scientific programs, by acquiring information concerning such matters as cosmic ray intensities, meteorites, solar radio waves and transmitting this to the internationally appointed agencies which store, collate and disseminate it.

The Royal Canadian Mounted Police use the National Crime Information Centre in Washington, D.C. for the purpose of tracing criminals in connection with offences committed in Canada, plus exchange information on stolen motor vehicles and other identifiable stolen property. This information is also kept in Canada.

## COMMEMORATIVE STAMPS, MANITOBA CENTENNIAL

Question No. 1,013-Mr. Stewart (Marquette):

Were postage stamps issued to commemorate Manitoba's Centennial Year and, if so (a) was the Government of Manitoba consulted on the design of these stamps (b) when were they consulted (c) who was consulted and did they approve?

Kierans (Postmaster General and Minister of Communications): Yes; (a) No; (b) Not applicable; (c) The Manitoba Centennial Corporation was advised on November 25, 1965, of the department's intention to issue a stamp to commemorate Manitoba's Centennial Year and was invited to submit design proposals. No design proposals were submitted, however, and the only further contact in this regard was to advise the Corporation as to the appointment of a designer.
