I therefore find, in examining them—and I have to come to a decision one way or another—that there is a serious dispute and disagreement as to what the facts were, and there is a further dispute and disagreement as to what implications or significance should be taken from those facts. Those are ingredients for debate and not ingredients for a question of privilege. Therefore, that is my view and it is my hope that the matter will end there.

AMENDMENT TO EXTEND LICENSING REQUIREMENT TO RIFLES

Mr. Stuart Leggatt (New Westminster) moved for leave to introduce Bill C-392, to amend the Criminal Code (control of weapons and firearms).

Some hon. Members: Explain.

Mr. Leggatt: Mr. Speaker, the purpose of this bill is to place firearms which are not now prohibited or restricted, in the restricted category and require a licensing system for the ownership of all firearms. The purpose, in short, is with some exceptions to apply to rifles the law presently in place with respect to handguns.

CONTRACT TO CARLETON UNIVERSITY FACULTY OF ENGINEERING

Question No. 1,979-Mr. Reynolds:

- 1. Was a contract awarded February 20, 1974 to the Carleton University Faculty of Engineering, Ottawa, Ontario for a study testing the capability of interactive video communications systems?
 - 2. What is the necessity of the study?
- 3. Could the information have been available elsewhere as assessed by other governments or with the Department of Communications?

Hon. Gérard Pelletier (Minister of Communications): 1. Yes, the contract was issued on January 30, 1974.

- 2. The study was initiated by the Educational Technology Program Branch of the Department of Communications to assist the Provinces in the field of educational technology. The overall objective of the Wired City Simulation Project is to evaluate and demonstrate the techniques, economics and utility of integrating two way interactive video communications into the education process. The Simulation Laboratory will provide the capability of evaluating several prototype systems.
- 3. The Department of Communications does not have this type of Laboratory and it is not available anywhere else in Canada.
