## STATEMENT BY PRESIDENT OF TREASURY BOARD

**Hon. Jean Chrétien (President of the Treasury Board):** Mr. Speaker, I wish to present a message which Your Honour read to the House and by which His Excellency the Governor General is transmitting estimates for the service of Canada for the financial year ending March 31, 1977.

Mr. Speaker, the main estimates for 1976-77, which I am tabling today, amount to \$38.4 billion for budgetary items and \$1.1 billion for non-budgetary items. They include for the first time old age security and guaranteed income supplement payments, which in other years were paid out of a special account.

Throughout the current fiscal year, I have—

**Mr. Speaker:** Order, please. I feel the hon. President of the Treasury Board is making a statement as a minister and this calls for an answer from representatives of all political parties in the House. In addition, there will be a question later. If such is the minister's intention, I urge him to continue, if not we shall have to remain at the document tabling stage.

**Mr. Baldwin:** Mr. Speaker, it is also my impression that the hon. gentleman slipped rapidly from the tabling of documents to statements by ministers without Your Honour calling that order of business. I was assuming that was the case and that it would be subject to the usual restrictions and the rights of hon. members on this side of the House.

**Mr. Speaker:** Order, please. I have the indication now from the minister that it is not his intention to make a statement at this time, but simply to table the document.

**Mr. Chrétien:** Mr. Speaker, I feel I must make a point clear. I believe it is in keeping with tradition to make a statement under those circumstances and shall do so after meeting with the other parties' representatives. However if it is deemed preferable that I do not make a statement, Mr. Speaker, we can—

**Mr. Speaker:** Order, please. I think it is now evident that the President of the Treasury Board seeks to make a statement which, of course, will be replied to by other hon. members and there will be a question period. There are still a number of routine proceedings, not the least of which is the point of order of the hon. member for Oshawa-Whitby. Therefore, I wonder if hon. members might agree that the statement by the minister, as has been our recent practice, might be deferred until the conclusion of routine proceedings in order to permit his statement, representations by other hon. members and questions to follow.
