**BUSINESS OF THE HOUSE**

**Hon. Ray Hnatyshyn (Minister of State (Government House Leader)):** Mr. Speaker, there have been consultations between the various House Leaders with respect to the business for tomorrow, at which time we are planning to have the economic statement. I have before me and want to present to the House for approval at this time, by unanimous consent, the following Order:

That, notwithstanding any Standing Order, on Thursday, November 8, 1984, at six o'clock p.m. the House shall suspend its sitting until 6:30 o'clock p.m., and, at that time the business to be considered shall be a statement by the Minister of Finance;

Provided that upon the conclusion of the statement the Minister may lay upon the Table certain Notices of Ways and Means Motions related thereto, and that after a reply to the statement from one Member of each of the other recognized Parties, the Speaker shall adjourn the House.

**Mr. Ian Deans (Hamilton Mountain):** Mr. Speaker, I simply want to acknowledge that in fact the consultations which the Hon. House Leader has indicated did take place, and in our consultations we recognized that, although this is an unusual situation, the length of speeches of Opposition Party Members responding to the speech would not be longer than the speech of the Minister of Finance (Mr. Wilson).
