**Hon. Perrin Beatty (Minister of National Health and Welfare):** Mr. Speaker, what we are seeing taking place is a process of consultation with Canadians. Between the time the Minister of Finance announced that consultations would take place and the present, we have had over 5,400 Canadians involved in consultations with the government with regard to the environment.

I take it from the hon. member that the Liberal Party of Canada opposes this sort of consultation with the people of Canada. For the government's part, it believes that Canadians have a right to be involved in determining policies relating to the very survival of this planet.

Recent reports indicate that the government is very hesitant about initiating deportation hearings against some business immigrants who have not honoured their end of the economic commitment which was the basis for their admission into Canada. I would ask the Deputy Prime Minister how the government can refuse to investigate such individuals when thousands of refugee family class or independent class applicants are scrutinized religiously and refused for the smallest of flaws? Why, in other words, the double standard, one for the rich and one for the not so rich.

**GUN CONTROL**

**Mr. Svend J. Robinson (Burnaby—Kingsway):** Mr. Speaker, my question is for the Minister of Justice.

The minister knows that hundreds of thousands of Canadians have signed petitions calling for more effective gun control in Canada, particularly with respect to military and paramilitary combat weapons, and that the Federation of Canadian Municipalities this month unanimously urged a ban on these weapons in civilian hands.

In view of the fact that the minister promised on May 10 of this year before the justice committee to table gun control legislation before the summer adjournment, why is she now backing off on this promise? Why is she now caving in to the vocal minority in this country who do not believe in any effective gun control legislation at all?
