TRADE ADJUSTMENT BENEFITS ACT

MEASURE TO ENACT

Hon. Lloyd Axworthy (Winnipeg South Centre) moved for leave to introduce Bill C-318, an act to provide for the payment of benefits to Canadian establishments laying off employees.

Madam Deputy Speaker: Is it the pleasure of the House that the hon. member shall have leave to introduce the bill?

Some hon. members: Agreed.

Mr. Axworthy (Winnipeg South Centre): Madam Speaker, the bill I am introducing is for the establishment of a trade adjustment review board that would have the responsibility of designating those industries or locales that are affected by substantial lay-offs or job dislocation caused by trade matters or other changes in the industrial area. It would then be able to provide or to utilize its powers to apply various benefits to workers under the present programming of the government, and also to provide ways of organizing these. I think it is a proper response to the major and serious industrial changes going on in Canada at the present time.

Motion agreed to, bill read the first time and ordered to be printed.
