LEIGHTON, JOHN STEWART. (*Carleton.*)

Of English descent. B. in Charlotte Co., N.B., 8 Nov. 1835. Ed. at the Common Sch. M., 17 Nov. 1864, Miss A. M. Collins, (she died 1874.) Is a farmer, lumberer, and a merchant. First returned to Ho. of Assem. at g.e. 1874, re-elected at g.e. 1878, and again at last g.e. A Liberal.—*Woodstock, N.B.*

LEWIS, WILLIAM JAMES. M.D. (*Albert.*)

Of Welsh descent. S. of Hon. John Lewis, M.L.C., N.B. B. at Hillsborough, N.B. 25 Sept. 1830. Ed. there and at Sackville, N.B. M., 1877, Melissa, dau. of Richard E. Steeves, Esq., of Hillsborough, N.B. A doctor of Medicine of the Univ. of Glasgow, and mem. of the College of Surgeons, Edinburgh, Scot., at which institution he graduated, 1855. Apptd. a mem. of the Ex. Council 5 July 1882. Resigned with his colleagues, Feb. 1883. First returned to Ho. of Assem. at g.e. 1878 and re-elected at last g.e. A Liberal Conservative. *Hillsborough, N.B.*
