

Ont. (she died 3rd June, 1874); 2nd, 26 Sept., 1876, Caroline, dau. of the late Senator Adam Hope of Hamilton, who also died 9th October, 1877. M., 3rd, 18 May, 1881, Eliza, dau. of the late Judge Malloch, of Brockville, Ont. For many years a member of Board of Education of Hamilton, of which he was Chairman two years. Elected member of Senate of Toronto Univ. 1873, and re-elected in 1878, 1883, 1888 and 1893. Was instrumental in organizing the Hamilton Art School, and was President of that institution for five years. An active member of the Volunteer Force, 1860, and commanded the 13th Batt. for several years, and is now Honorary Lt.-Col. of that Corps. Was with his Regt. as Lieut. at Ridgeway in 1866. Holds a first-class Military School Certificate. Has had a very high reputation as a marksman, having been a member of the Canadian Wimbledon Teams in 1874, 1875 and 1879, winning prizes on all these occasions. In 1879 he won the Prince of Wales' prize (a badge and £100). In 1881, he commanded the Canadian Wimbledon Team which defeated the British Team in the Rifle contest for the Rajah of Kolapore's cup. Was also a member of the Canadian Long Range Teams at Creedmoor 1876 and 1880. Was Presdt. of the Ontario Rifle Assoc. for three years. Was the first Presdt. of the Canadian Military Rifle League, and continued Presdt. for three years. Has been Presdt. of the Dominion Rifle Assoc. since 1892. Honorary Presdt. of Veterans' 66 Assoc. Presdt. of St. Andrew's Society of Hamilton for years 1890 and 1891. Was Grand Master of the Masonic Grand Lodge of Canada from July, 1892, to July, 1894. First returned to Leg. Assem. at g. e., 1879, and has since continued to represent the City of Hamilton. Has been Chairman of the Private Bills Committee each year from 1883. Entered the Ontario Government as Provincial Secretary in January 1889, being elected by acclamation. Apptd. Commr. of Crown Lands, 21 July, 1896. GIBSON, THOMAS (*East Huron*).

Grandfather was a native of Northumberland, Eng. S. of Mr. Thomas Gibson. B. at Greenlaw, Berwickshire, Scot., 8 Jan., 1825. Ed. there. M., 1st, 1854, Miss Elizabeth Hudson (she d.); 2nd, Sarah, eldest dau. of Richard Young, Esq. of Lakelet. Learned the trade of a millwright, and worked at it in Scotland some years, and also in Buffalo from 1853, before settling in Can. in 1854. Elected to the Municipal Council of Howick in 1858, and was Reeve for seven years. An unsuccessful candidate at g. e., 1867. First
