### Re Deficiencies at Distilleries.

SIR,—In your letter of July 9th, 1894, you stated that the returns of the distillers from the time that the establishment of the duties by weight was brought into force until the close of the fiscal year just passed were being amended, and when received and checked, you would communicate the result. I have not received this information and shall be glad to have it now. A summary of the transactions will probably be sufficient, showing the name of the distiller, the amount of the deficiency in each year as first returned, the amount to which it was reduced, and the date of payment.

I have also to ask for a statement of the deficiencies during the last fiscal year, together with the Inspectors' returns.
