7. Resolved, That a sum not exceeding Eight thousand dollars be granted to His Majesty, for Public Works Health Act, for the year ending 31st March, 1910.

8. Resolved, That a sum not exceeding One thousand two hundred dollars be granted to His Majesty, for Pensions-Mrs. William Macdougall, for the year ending 31st March, 1910.

9. Resolved, That a sum not exceeding Four hundred dollars be granted to His Majesty, for Pensions-Mrs. Delaney, for the year ending 31st March, 1910.

10. Resolved, That a sum not exceeding One hundred and sixteen dollars and seventy-six cents be granted to His Majesty, for compensation to Pensioners in lieu of land, for the year ending 31st March, 1910.
