LENNOXVILLE EXPERIMENTAL FARM.

Mr. TOBIN:

1. Before the purchase of the experimental farm in the Eastern Townships at Lennoxville, Quebec, were any farms examined on behalf of the Government by Mr. Duncan Anderson, in the electoral division of Richmond and Wolfe?

2. If so, where are the said farms situated, and what are the names of the proprietors of the said farms?

3. What was the price demanded by the

proprietors of each of the said farms?

4. If any price was offered by Mr. Anderson on behalf of the Government, what was the amount of the said offer in each case?

Mr. BURRELL:

1. Yes. Several farms were examined in the county of Richmond.

2. Close to the town of Richmond. Owned by Mr. Lemoine and Mr. Fortier. Also the farms owned by Messrs. Beattie Bros., and Mr. Berwick. They are situated about four miles north of the city of Sherbrooke, in the county of Richmond.

3. The price asked by Mr. Berwick was \$10,000. Messrs. Beattie Bros. offered their farm at the same price, \$10,000. No value was placed on the farms examined near the town of Richmond.

4. No offer was made by Mr. Duncan Anderson on behalf of the Government for any of these farms.

RIMOUSKI CUSTOMS OFFICERS.

1. What is the salary of Mr. Omer Beaulieu, customs officer at Rimouski, and of his assistant, Mr. L. O. Lavallee?

1. The salary of Mr. Omer Beaulieu, collector of customs at Rimouski, is \$900; that of his assistant, Mr. L. O. Lavallee, preventive officer, is \$400.

2. The salary of Mr. Martin Lapage, collector of customs at Rimouski, was \$800 prior to 1911; but on April 1, 1911, it was increased to \$900. The salary of his assistant, Mr. J. S. Gauvreau, acting preventive officer, was \$300 prior to 1911; but on April 1, 1911, it was increased to \$400.
