**ELECTORAL BOUNDARIES READJUSTMENT ACT**

MEASURE TO CHANGE NAME OF CONSTITUENCY FROM HULL  
TO HULL-AYLMER

**Mr. Gaston Isabelle (Hull)** moved for leave to introduce Bill C-205, An Act to change the name of the electoral district of Hull.

**Some Hon. Members:** Explain.

**Mr. Isabelle:** Mr. Speaker, this bill, which concerns the constituency of Hull, aims at adding the name of Aylmer to the present designation of the riding.

The new federal constituency of Hull includes the voters of only two cities, Hull and Aylmer. It would therefore be logical and justifiable for these constituents to be identified and known by a designation which represents all of them, namely Hull-Aylmer.

Mr. Speaker, this is basically what this bill is all about.

**BRITISH NORTH AMERICA ACT, 1867**

MEASURE TO CHANGE BOUNDARIES OF NATIONAL CAPITAL

**Mr. Gaston Isabelle (Hull)** moved for leave to introduce Bill C-206, an Act to amend the British North America Act, 1867 (national capital of Canada).

**Some Hon. Members:** Explain.

**Mr. Isabelle:** Mr. Speaker, this bill aims at changing the boundaries of the national capital of Canada to include the city of Hull and any other area that the Canadian Parliament could designate in the future. In other words, this constitutional amendment would authorize Parliament by legislation to include in the national capital all areas located within the national capital region.
