Finally, I want to say this. I think Madam Sauvé's ruling on a case very similar to this is in fact very pointed. I would like to refer to one quotation at page 3781 of *Hansard*. She said:

Rather, the advertising referred to by Members seems to deal with the issue of the constitution rather than the proceedings of the House.

We could take exactly the same words here, changing one. Rather, the advertising referred to by members seems to deal with the issue of the GST, as opposed to Constitution, rather than the proceedings of the House. In other words, Madam Sauvé found that the issue that she was dealing with at that time was not a contempt, was not a privilege; and, of course, we are in exactly the same situation today. Our proceedings continue whether they be here in the House of Commons or whether they be in committee. Our individual Members have not in any way been hampered or tampered with or intimidated in any way to prevent them from participating in this debate. The debate continues today. The debate will continue for some time to come, and the House will come to its decision. There is in no way either a privilege or a contempt. I think Madam Sauvé's ruling applies very specifically.
