Item No. 2 on today's list standing in the name of the hon. member for Waterloo would be No. 2 on the list, and No. 1 on the list would be the motion standing in the name of the hon. member for Hamilton West.

Accordingly, that motion would be called for debate at one o'clock on Monday. I would ask that the appropriate adjustments be made in the Order Paper for Monday. I believe there is unanimous agreement that that be done.

The Acting Speaker (Mr. Paproski): Hon. members heard the terms of the motion. Is it agreed?

Mr. Svend J. Robinson (Burnaby—Kingsway): Mr. Speaker, I wonder if I might just take this opportunity on a point of order to ask a question relating to House business. As the House Leader knows, these proposals are strongly supported on all sides of the House. I am certainly prepared to undertake our commitment to facilitate speedy passage. I wonder if perhaps he might indicate willingness to bring them forward early next week.

Hon. Harvie Andre (Minister of State and Leader of the Government in the House of Commons): Mr. Speak-

er, there is no question that that bill and a considerable number of other bills are very important to Canadians and to the government as well as Canadians who await the passage of these bills. It is for that reason that I meet with the House leader of the Official Opposition and the House leader of the hon. member's party to sit and plan in a reasonable way the efficient conduct of business of this House.

I appreciate the hon. member's suggestion that he will be talking with his colleagues to facilitate those kinds of discussions and I look forward to that.
