Government allowed the Pacific Railway Company to select Kicking Horse Pass after the line was located through Yellow Head Pass.

HON. SIR ALEX. CAMPBELL-The law was changed in that respect and the Company were allowed to change the location.

HON. MR. KAULBACH-I quite agree with what my hon, friend the leader of the Government has said that the Government will not do an illegal thing, but they will put the buildings up where the law directs. What the people who have invested at Port Moody on the strength of the pledge of the Government that the terminus would be there say is, that tenders were out for the buildings at Port Moody, and they were withdrawn. Tenders were received for the work, and we understand from high authority that those tenders were not accepted in consequence of the Pacific Leonard, Railway Company intending to extend the McClelan, line down to English Bay, and it would be very much left to their disposal to say where the terminal buildings would be.
