Speaker's Warrant to the Clerk of the Crown in Chancery, directing him to alter Return to Writ of Election, and Certificate of latter Officer that Return to Writ had been so altered, 248-250.

**Emigrant Building and Quarantine Station, Lévis:**—Motion for an Address—Correspondence between Canadian Pacific Railway Company and the Government for the removal of the Emigrant Building, etc., at Lévis from Lévis to Montreal; Debate arising thereon; Motion withdrawn, 108.

**Emigration from Canada:**—Address—Correspondence with the American Government relating to Statistics of Emigration from Canada to the United States, since 1873: Mr. Charlton, 438.

**Erie and Huron Railway Company of Ontario:**

1. Petition for an Act to further extend the time limited for the completion of their Railway, 147. Report of Notice, 159. Bill (No. 85) presented: Mr. Smyth, 166. Read second time and referred to Committee on Railways, etc., 237. Reported amended, 367. Considered in Committee; reported; read third time; passed, 375. Passed by the Senate with an amendment; concurred in, 452. Royal Assent, 638.—47 Victoria, Chapter 68.
2. Petitions that assistance may be granted said Company to enable them to extend their line from Wallaceburg to Sarnia, 235, 274.
