Mr. MacDonald (Egmont), seconded by Mr. Baker, moved,—That, in the opinion of this House, the government should take the lead in establishing a World Commission on Food and Resources, under the auspices of the United Nations, to compile a comprehensive and regular inventory of the existing world foodstuffs and resources essential for sustenance; each nation shall be required to report annually (with quarterly amendments) on the state of its own self-sufficiency and on its ability to transfer key foodstuffs and resources to more needy nations; the Commission shall have the authority to transfer designated food and resources from member nations equal in amount to their expenditures on defence.—(Notice of Motion No. 1).

And debate arising thereon;
