#### CANADA LANDS SURVEYS ACT

MEASURE TO AMEND CERTAIN PROVISIONS OF THE ACT

The House resumed consideration of the motion of Mr. Lang (for Mr. Gillespie) that Bill C-4, to amend the Canada Lands Surveys Act, be read the second time and referred to the Standing Committee on National Resources and Public Works.

Mr. Maurice Dupras (Parliamentary Secretary to Minister of Energy, Mines and Resources): Mr. Speaker, when the House rose for lunch at one o'clock today I was trying to indicate some of the feelings of my compatriots across the country with regard to the nomenclature of some of the Crown corporations and agencies, and I indicated that there was no sinister intention in calling the new bill the Canada Lands Surveys Act. In fact, this has been the name of the act since 1952, by amendment.

[Translation]

The title of this law is not new; since 1952, through an amendment, it has been changed to Canada Lands Surveys Act. My colleague from Bellechasse (Mr. Lambert) recalled the valuable services rendered by land surveyors who obtained their certificate through a period of apprenticeship while on the job. The great contribution of these men has been to complete the documents on surveying in Canada. My colleague from Timiskaming (Mr. Peters) was wondering if there had not been any violation of Indian territories by giving a favourable presumption to the Canada Lands Surveyor, that is, by allowing him, under the law, to pass through their territory to conduct his work. Indians have expressed very little resistance to this type of activity and I do not believe this new legislation will create any problems.

I would not want to extend the debate on this bill. Therefore, without minimizing its scope, I understand an agreement has been made among party leaders so that the three stages of the bill will take place in the House and consideration in committee could take place in committee of the whole. My colleagues might accept this arrangement and proceed to consideration of the bill in committee of the whole.
