

Reaches Shag Harbor. A dispatch from Shag Harbor tonight says the Niobe has arrived there under her own steam and is anchored in nine fathoms water. She was conveyed to the harbor by a tug from Yarmouth, Shag Harbor is ten miles west of the place where she struck.

Quick Work. The grounding of the Canadian flag- ship Niobe at Cape Sable Saturday night resulted in a hurried call for assistance here and the government steamers Lady Laurier and Stanley, which happened to be here together loading supplies, put to sea at all haste at about 5 o'clock yesterday morning. G. H. Flood, marine agent, re- ceived a telephone message from Mr. Stanley, the marine agent at Halifax, request- ing that help be sent to the stranded cruiser. A message was sent to the two government vessels and no time was lost in getting up steam. The Stanley was laden with concrete and other material for repair work on the various light- houses, and also had coal and other supplies, and the Lady Laurier was to take some buoy down the bay. As much as possible was taken off the steamers on the way and almost together they swung out into the stream and headed out in the bay. This was within an hour after Mr. Flood got word of the mishap. There was much to contend with as besides a heavy sea running there was a strong breeze. The two were not long outside when they were in wireless communication with the Niobe and were able to advise the warship that they were on their way.

American Outer Thore. A wireless message to The Telegraph is to the effect that the first to come to the aid of the stranded cruiser was the American revenue cutter Androssoggin. The cutter was cruising in the vicinity and picked up the wireless call for help from the Niobe. She replied at once that she was standing by and was ready to render assistance. The Lady Laurier and Stan- ley reached West Bay late yesterday afternoon and the Yarmouth tug McNaughton and cutter Androssoggin, stood ready to render assistance. The Telegraph's mis- sionary cutter had made temporary repairs to the bottom of the vessel stopping up the open- ings made by the rocks. It was stated that the Niobe was anchored in a good place with six fathoms of water and a mud bottom. She was reported perfectly safe and would be taken to Halifax, it was said, when the weather permitted.
