WAR MEASURES ACT—SUGGESTED INDEPENDENT COMMISSION TO SUPERVISE APPLICATION OF REGULATIONS

Mr. David Lewis (York South): Mr. Speaker, I do not know whether the Solicitor General has been in touch with this matter, but last Wednesday I asked the Minister of Justice whether he or any other minister of the government or the Attorney General of Quebec was considering the appointment of an independent committee to be in contact with the people arrested, a suggestion that is now supported, I believe, by all the churches of Canada. May I ask the Solicitor General whether he knows if this is being considered and if there is any intention of appointing such a committee?

Hon. G. J. McIlraith (Solicitor General): I do not know, Mr. Speaker, that there is a great deal I can usefully add to what the Minister of Justice has said on this subject—

Mr. Lewis: The minister said that he would draw it to the attention of the Attorney General of Quebec.

Mr. McIlraith: I thank the hon. member for correcting his leader on that point. There is very little I can add to what the Minister of Justice said in explaining the situation to the House. It is my understanding that it is being considered by the justice minister of the province under whose immediate responsibility the matter falls.

Besides, those letters have appeared in the official report of the House of Commons' debates.
