APPEARANCE OF CANADIAN PHARMACEUTI-CAL ASSOCIATION BEFORE FEDERAL-PRO-VINCIAL COMMITTEE ON PRICES

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, my question is for the Minister of Consumer and Corporate Affairs. Has the minister received a request from the Canadian Pharmaceutical Association to appear before the federal-provincial committee on drug prices and, if so, what reply has he given to that request?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, the meeting being held in Ottawa today is a federal-provincial meeting of officials at both levels of government. It certainly is not the practice to have people from the private sector present at such meetings.

Mr. Dinsdale: A supplementary question, Mr. Speaker. In view of the high cost of drugs, would the minister arrange to meet with representatives of the association who are anxious to offer advice on how the cost of drugs can be lowered?

Mr. Basford: Mr. Speaker, I indicated to the association that following the conference there undoubtedly would be consultation.

SETTLEMENT OF WEST COAST TOWBOAT STRIKE—RELEASE FROM JAIL OF UNION MEMBER

Mr. Thomas S. Barnett (Comox-Alberni): Mr. Speaker, may I address a question to the Minister of Labour relating to or arising out of the response he gave to the first question asked about the towboat situation in British Columbia. Could the minister tell us whether part of the settlement involves any form of truce in the legal conflicts which have surrounded this dispute? If so, could he state whether this might lead to the release from jail of a member of the union who is at the moment, I understand, in jail?

Hon. Bryce Mackasey (Minister of Labour): No, Mr. Speaker, I think such a conditional settlement would be an interference with the due process of the law. I am not a lawyer but I would presume that in the case of this particular official the matter would no doubt be reviewed by his lawyer and possibly there are appeal procedures. Certainly the settlement was not conditional on the release of any union member under sentence for contempt

of court. One of the beneficial effects of the proposed settlement is I understand all secondary picketing will be removed immediately in British Columbia and this should do a lot to remove one source of irritation.

Mr. Barnett: Mr. Speaker, may I direct a supplementary question to the Minister of Justice arising out of a question asked on Monday in his absence concerning, whether he sees any role that he might be able to play in bringing about the release of this union member, particularly now—
