MR. OLSON—WORDS USED IN DEBATE BY MEMBER FOR MACKENZIE

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, on a question of privilege, I would like to draw your attention to Hansard, page 8127, the righthand column, where the hon. member for Mackenzie is reported as having said while I had the floor: "You are a damn liar and a crook." I did not hear the hon. member say that or I would have raised the matter immediately. However, the remark is reported in Hansard. I am not sure of the procedure, but perhaps I should give notice that I wish to raise this question and ask the hon. member to withdraw those words when he is in the House. He is not here now.

Mr. Speaker: The minister is, of course, doing the right thing in raising the matter at this time. I am sure that the hon. member concerned would want to withdraw the remarks which unfortunately got on the record in *Hansard*. I am sure that all hon. members will agree that words of this kind are unparliamentary and no hon. member, even in the heat of debate, would want to be reported as having said them. For the moment, however, the matter will not be pursued further.

SMALL BUSINESS AND FISHERIES IMPROVEMENT LOANS—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O 43

Mr. Jack Marshall (Humber-St. George's-St. Barbe): Mr. Speaker, I ask the unanimous consent of the House to propose a motion under Standing Order 43 in a case of urgent necessity.

The latest reports concerning small business loans and fisheries improvement loans reflect a dereliction of the duty of Canadian banks to support the government by injecting impetus into the small business sector of the Canadian economy. In spite of the extra effort required of Canadian banks to increase this support, the figures disclosed indicate a reduction in the number of loans granted and in the amounts granted. Further indications are that Canadian banks are steering applicants away from government guaranteed loans at preferred rates of interest in order to take advantage of the higher conventional bank rates.
