Hon. Andrée Champagne (Minister of State (Youth)): Mr. Speaker, I apologized because there seemed to be an understanding by some people that there was an intent to use taxpayers' money for partisan purposes. Such was not the intent, and the letter was misinterpreted.

I also admitted that the writing of the letter was a mistake and I have apologized for that. There was never any such intent, so I think that this is all there is to it.
