(a) by striking out line 19 at page 14 and substituting the following therefor:

"(b) in the case of a claimant who is the subject of an inquiry caused pursuant to paragraph 23(3)(c), the claimant came to Canada from"

(b) by striking out lines 19 to 24 at page 17 and substituting the following therefor:

"48.03(1) Where a removal order is made against a claimant who has been determined not to be eligible to have a claim determined by the Refugee Division on the basis that the claimant is a person described in paragraph 48.01(b), but"

(c) by striking out lines 19 and 20 at page 20 and substituting the following therefor:

"but for the removal order, eligible to be granted landing."

(d) by striking out line 24 at page 20 in the English version and substituting the following therefor:

"for the removal order,"

(e) by striking out lines 11 to 15 at page 21 and substituting the following therefor:

"reason other than the removal order; or

(e) the person was determined to be, but for the removal order, eligible to be granted landing."

(f) by striking out line 27 at page 21 and substituting the following therefor:

"order, the person is"

(g) by striking out lines 40 to 42 at page 21 and substituting the following therefor:
