### POSSIBLE CLOSURE OF CN SHOPS IN MONCTON

Mr. Fernand Robichaud (Westmorland—Kent): Mr. Speaker, my question is directed to the Minister of Transport.

## [English]

The Minister of Transportation for the Province of New Brunswick recently said in the New Brunswick Legislature that the federal Minister of Transport had given him assurances last winter that the CN shops in Moncton were not in danger of being closed in the foreseeable future. Is that statement fact or fiction? Did the Minister give those assurances to the provincial Minister?

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, the Hon. Member is clearly aware that this is an issue that CN has been wrestling with for quite some time as part of a survey of its maintenance shops right across the country. There will have to be some adjustment and rationalization and consolidation. When a decision is finally agreed to and taken to the board and management of CN, I will be in a position to respond in a more appropriate fashion.

### MINISTER'S POSITION

Mr. Fernand Robichaud (Westmorland—Kent): Mr. Speaker, would the Minister please answer my question. Did he give assurances to the provincial Minister of Transportation that the jobs in Moncton would be protected?

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, I have said on a number of occasions that there would not be, I would hope, any massive lay-offs. What we are trying to do is work towards the maintenance of the largest number of employees possible under any adjustment or rationalization.
