

**COMPANY OF YOUNG CANADIANS****REQUEST FOR REPORT ON STATUS OF PROGRAMMING FUNCTION**

**Mr. Stan Schumacher (Palliser):** Mr. Speaker, I should like to direct this question to the Secretary of State and preface it by saying it has nothing to do with asking for an amendment to the act establishing the Company of Young Canadians. In light of the elections now in progress to establish a permanent council of the Company of Young Canadians, will the minister say whether anything is being done to alter the original intention or structure of the Company of Young Canadians before the permanent council has been elected and has met, and in particular will he report to the house upon the status of the program department of the company?

**Mr. Speaker:** It seems to me that the statement the hon. member is asking for at this time should normally be made on motions. Perhaps the hon. member might invite the minister to make such a statement on motions.

**Mr. Schumacher:** Thank you, Mr. Speaker. I ask the minister whether he would be prepared to make a statement at an early opportunity before these elections have been completed. If necessary, I would ask for the unanimous consent of the house for the minister to make a statement at this time.

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, the short answer to that question is no; it is in no way our intention. If the hon. member wants to ask for supplementary explanations, perhaps he could address them to the minister who speaks for the government on Indian affairs.
