REQUEST FOR MEASURES TO AVERT BANKRUPTCIES

Hon. Michael Wilson (Etobicoke Centre): Madam Speaker, my question is for the Minister of Finance. Yesterday, before the Standing Committee on Finance, Trade and Economic Affairs, the chairman of the Trust Companies Association said that there could be casualties in that industry if the present economic conditions last for another six months. Since many

companies in other industries besides that one are now talking in terms of how many months they will be able to survive under the economic conditions which exist today, will the minister commit to the House that he will present alternative policies in his forthcoming financial statement that will avoid those disasters and lay-offs which will come if companies go bust over the next six months?

Hon. Allan J. MacEachen (Deputy Prime Minister and Minister of Finance): Madam Speaker, I cannot give the hon. member a preview of what will be in that statement. I have already indicated to his leader that I intend to make a financial and economic statement, in the words of the Leader of the Opposition. I have assured hon. members that it will be made in the House. I cannot give the hon. member any preview of what will be in that statement at the present time.

POSITION OF MINISTER

What I am asking, and what Canadians are asking, is whether there is any sense of understanding on the part of the minister that there is a crisis on our hands. The minister's head is in the sand.
