## FIELD GENERAL COURT-MARTIAL

(Whether the accused to be tried is under his comid or not, a FGCM may on application to him be convened by any offr of Cdn Army Overseas, or of any other force if authorized in law, in immediate cand of troops on active service, subject to RP 105(C) and restrictions imposed by appropriate authy. As 49, 50, RP 104-107, 114. As to the duties and privileges of the Convening Offr in dealing with the application see MML Chap Y perses 20 and 23, RP 87(6).

There should be a separate Convening Order for each person to be tried sebatorately by the same Court. RP 71(C), 109. As to separate charge sheets the RP 61, and as to separate trial on charges in the same charge sheets see RP 108. As to two or more accused charged jointly see RP 16. 109.
