That the Clerk of this House be authorized and required to pay on this day to to the Officers, Clerks and Servants belonging to the Legislative Council their full month's Salaries and allowances for the current month of August, as recognized and settled by this House; and also in future that he do pay such salaries and allowances to them on the first instead of the last day of each and every succeeding month (the foregoing resolution is in explanation of the motion adopted on Saturday last, the eleventh day of August instant, on the same subject). That a gratuity be paid to each of the Officers, Clerks and Servants of this House in the following proportions:—To those whose salaries do not exceed one thousand dollars per annum at the rate of ten per cent on such salaries to those whose salaries exceed one thousand dollars per annum at the rate of five per cent on such salaries; provided however that no Officer, Clerk or Servant whose salary exceeds one thousand dollars shall receive less than one hundred dollars gratuity.
