## Section 3

Officers of Council.

The Council shall elect, and determine the emoluments of, and President, for a term not to exceed the interim period. The President shall have no yets. The Country of the interim period. shall have no vote. The Council shall also elect from among its members one or more Vice Presidents, who shall retain their right to vote when serving as Acting President. Decisions by the Council will be deemed valid only when approved by a majority of all the members of the Council.

## Section 4

Participation in matters before Council.

Any member State not a member of the Council may participate to deliberations of the Council may participate in the deliberations of the Council whenever any decision is to be taken which especially concerns and which especially concerns such member State.
