Mr. Guay (Lévis) for Mr. Goode, from the Standing Committee on Fisheries and Forestry, presented the Second Report of the said Committee, which is as follows:

And on the motion of Mr. Schumacher, seconded by Mr. Cadieu, in amendment thereto,—That this Bill be not now read a second time but that it be read a second time this day six months hence.
