Strike out line 23, on page 39, and substitute the following therefor:

"or persons because of the low pricing policy of that person or class of persons."

Add immediately after line 39, on page 39, the follow-ing:

"(7.1) For the purposes of this section, a company is deemed to be controlled by a person if shares of the company carrying voting rights sufficient to elect a majority of the directors of the company are held, other than by way of security only, by or on behalf of that person."

Strike out line 43, on page 39, and substitute the following therefor:

"to imprisonment not exceeding five years."

Add immediately after line 43, on page 39, the following:

"(9) Where, in a prosecution under paragraph (1)(b), it is proved that the person charged refused or counselled the refusal to supply a product to any other person, no inference unfavourable to the person charged shall be drawn from such evidence if he satisfies the court that he and any one upon whose report he depended had reasonable cause to believe and did believe

(a) that the other person was making a practice of using products supplied by the person charged as loss-leaders, that is to say, not for the purpose of making a profit thereon but for purposes of advertising;

(b) that the other person was making a practice of using products supplied by the person charged not for the purpose of selling such products at a profit but for the purpose of attracting customers to his store in the hope of selling them other products;

(c) that the other person was making a practice of engaging in misleading advertising in respect of products supplied by the person charged; or

(d) that the other person made a practice of not providing the level of servicing that purchasers of such products might reasonably expect from such other person."

## Clause 19

Strike out line 11, on page 40, and substitute the following therefor:

"19. (1) Subsection 44(2) of the said Act is"

Add immediately after line 18, on page 40, the following:

"(2) Section 44 of the said Act is further amended by adding thereto the following subsection:

"(5) Proceedings in respect of an offence that is declared by this Act to be punishable on summary conviction may be instituted at any time after the subject-matter of the proceedings arose.""

## Clause 22

Strike out lines 26 to 34, on page 43, and substitute the following therefor:

"(2) Any person against whom a record or report of statistics referred to in section 45.1 is produced may require, for the purposes of cross-examination, the attendance of any person under whose supervision the record or report was prepared.

(3) Any person against whom a record or report of statistics referred to in section 45.2 is produced may require, for the purposes of cross-examination, the attendance of any person who participated in the preparation of the record or report."

## Clause 24

Strike out line 6, on page 45, and substitute the following therefor:

"imprisonment not exceeding five years; or"

Strike out lines 8 and 9, on page 45, and substitute the following therefor:

"in the discretion of the court and to imprisonment not exceeding one year, or to"
