I do so with particular reference to the announcement made the night before last that the price of Canadian No. 1 hard wheat had been reduced 10% cents. That is the largest reduction that has been made in many years in the price of Canadian wheat.

> I do not propose to go into detail about the number of bushels on hand or the fact that we have the largest surplus ever stored on the farms of western Canada because those facts have all been discussed on various occasions. Every hon. member who has kept in touch with this situation in any way is fully aware of the fact that for various reasons our elevators are full, our general storage capacity is occupied and that grain is stored in unprecedented quantities on the farms in western Canada.

The announcement made the day before yesterday of this large reduction in the price of wheat, varying according to the various grades, is one that is of great importance, not only to the wheat farmers of western Canada and the wheat farmers in other parts of Canada but also to every Canadian. That announcement lopped off many millions of dollars in immediate value of accumulated wheat, a fact which means a direct loss to the farmers themselves. That loss, in turn, is something which has its impact upon the retailers, the wholesalers, the railways, the producers in eastern Canada and, generally, upon our whole economy.

Without going into many of the arguments that might be presented as to the reasons for the situation with which we are now confronted, may I say I think it must be realized that the most urgent thing required at this time is a clear declaration of policy by the government so that the farmers, those handling grain, the railways, the shippers generally and the ship owners who will be called upon to carry the grain to distant points may know what to expect during the coming weeks and months.

Although the situation had been generally known, it came as a surprise to many Canadians to learn a few months ago that at the beginning of this year none of the 1953 wheat crop had been sold and that there had been a carry-over of a large quantity of the 1952 crop. Today we are within less than two avail myself of this motion in order to raise months of the opening of a new crop year.
