nessy hospital in Vancouver where the rates of pay for nursing orderlies is not as much as is received for those engaged in similar activities in other hospitals.

There was a reference to this matter earlier today, but I wanted to call it to the attention of the government once again. I believe the high turnover in orderlies in the hospital could militate against the best interests of the veterans who are receiving attention there. I received a communication from the minister saying this matter was under review and they were trying to resolve it. They have been doing this for a long time. I want to urge the government to really become earnest about this proposition and arrive at a speedy decision so our veterans will not be placed in a position where they have to put up with less than the best in hospital care.

**Mr. Coates:** I want to make one observation. We might as well be accurate and change the calendar to April 3, because that is what it is.
