1. Is it planned that camp Borden shall be a combined army training camp (armour, artillery, engineers and infantry) with only two messes being retained?

Hon. Léo Cadieux (Associate Minister of National Defence): 1. Canadian forces base Borden is part of training command and any proposals for modification of the command organization will be made by the commander training command. The feasibility of amalgamating certain training establishments on the base is being examined but no plan has been submitted yet. In the interests of efficiency, four messes in Canadian forces base Borden were closed recently. One was the headquarters officers' mess. The others were two sergeants' messes and one men's mess
