#### PROCEDURAL IMPLICATIONS OF FOURTH REPORT OF STANDING COMMITTEE

**Mr. Speaker:** Order. May I be permitted to refer at this time to the fourth report of the Standing Committee on Miscellaneous Estimates which appears in yesterday's Votes and Proceedings and is reported at page 615. The Chair has looked at this report, and I have to inform the House that I have serious misgivings as to its procedural implications. It has procedural implications not only because it appears to go beyond the terms of the royal recommendation but also because it might complicate things next week in view of the timetable for supply proceedings.

I would think that the House Leaders may want to consult in this regard. I will be in touch with them so that some decision may be reached on whether there may be some way by which this report can be considered by the House or amended, according to the wish of hon. members.

Mr. G. W. Baldwin (Peace River): Mr. Speaker, may I comment very briefly. I had this thought in mind, and I realize that when we get into supplementary estimates items of this kind can create many problems. I am not going to go into detail now, but I do feel that discussion might be resumed later. On behalf of our party I believe I can indicate that, if the government is willing to make certain approaches with regard to waivers of some of the Standing Orders, then in effect any defect may be cured. However, I think the matter should be discussed on the floor of the House, and so there will be no repetition I shall defer my remarks till either later today or Monday.
