BRITISH NORTH AMERICA ACTS

AMENDMENTS RESPECTING DISSOLUTION AND TERM OF PARLIAMENT

Mr. Doug Rowland (Selkirk) moved for leave to introduce Bill C-206, to amend the British North America Acts, 1867 to 1965 (Duration of House of Commons).

Some hon. Members: Explain.

Mr. Rowland: Mr. Speaker, this bill is designed to be a small step in the direction of returning the focus of government in this country to Parliament, where it belongs. The measures advocated in the bill would, hopefully, increase the influence of the individual Members of Parliament through broadening the range of issues upon which free votes would be possible, thereby strengthening Parliament's role in the policy formation process. Specifically, the bill would take away the right of the Prime Minister to recommend dissolution of Parliament and place that power in the hands of Parliament by establishing a set term of four years for Parliament, except—

Mr. Speaker: Order, please. I have to interrupt the hon. member to remind him that he cannot make the statement at this time which he would normally make on second reading. He can only explain the bill briefly. I am not sure whether the hon. member considers his statement to be brief, but he should bring it to a close as quickly as possible.

Mr. Rowland: For me, Mr. Speaker, this is brief. I will bring it to a close as quickly as possible. The bill establishes a set term of four years for Parliament, except in the eventuality that the government is defeated on a specific motion of want of confidence, or if it is defeated on a bill or a portion of a bill—

Mr. Speaker: Order, please. Unfortunately for the hon. member, the standards of brevity which apply are the Speaker's standards, and the hon. member has exceeded those standards. I must therefore ask the House whether the hon. member has leave to introduce the said bill.

Some hon. Members: Agreed.

Motion agreed to, bill read the first time and ordered to be printed.
