POSSIBILITY OF U.S. CATTLE GIVEN
DIETHYLSTILBESTROL ENTERING CANADA DESPITE
CANADIAN SUSPENSION OF USE OF DRUG

Mr. Bert Hargrave (Medicine Hat): Mr. Speaker, I wish to address a question to the Minister of Agriculture with regard to the use of diethylstilbestrol or DES as it is commonly known in the cattle feeding industry. Is the minister aware that after May 1 it will be possible for United States fed cattle that have been quite properly finished with DES implants to enter Canada for slaughter in spite of the Canadian suspension of the use of DES implants? If so, what is his department prepared to do about this situation?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, I am aware that research is being carried on in the United States and we have some of our officials in the United States observing this research to learn their findings. I am not aware that the report is finalized. Until that report is finalized and brought to my attention, I am not in a position to make a decision.

Mr. Hargrave: Is the minister aware of the unfair advantage United States cattle feeders will have over Canadian feeders because of our loss of the use of DES and a resulting feeding efficiency loss of some 10 to 15 per cent as a result of this imbalance in Canada-United States DES regulations on this product? If so, what will he do about it?

Mr. Whelan: As I said, Mr. Speaker, I am aware of the study that is being carried on. I am hoping this report will come forward early in February. At least, this is what I have been told. I am also aware of the disadvantage our producers will be under if American producers are allowed to use the product DES, as it is commonly referred to, in the United States. I am willing to go as far as discussing the matter with my counterpart in the United States. I have also discussed it with the Minister of National Health and Welfare for Canada to find out where we will go from there if the use of DES is still allowed in the United States.

CONSULTATION WITH PROVINCES BEFORE AMENDING OLD AGE SECURITY ACT

Mr. René Matte (Champlain): Mr. Speaker, I should like to put a question to the Minister of National Health and Welfare.

Does he intend to follow up the wishes expressed by the Quebec Minister of Social Affairs concerning the necessity to hold a federal-provincial conference before amending the Old Age Pensions Act?

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, in this connection I received a letter from the Quebec Minister of Social Affairs. As a matter of fact, I am going to meet him as well as my provincial counterparts within the next few days on the occasion of a federal-provincial conference of health ministers. Following these consultations, we will take advisement on what steps to take next.
